Each speaker is limited to two minutes.</p> <p>The consortium welcomed Consultant, Nancy Miller who flew in town to be present at today's SOCRC meeting.</p> <p>Will: TUSD had the benefit of both SC and IVC giving presentations to students for future transitions. Lots of questions on our campus about it.</p> <p>Karima: Thank you to Chantelle for organizing all of the classroom visits for the consortium presentations.</p> <p>Chantelle: We presented specifically to the Intermediate and Advanced AESL students on all programs in SOCRC, and they were very excited to hear about our tuition-free options related to transition pathways and opportunities. In addition to classroom visits, this year we included tabling opportunities where students had the chance to ask individual questions related to their interest.</p> <p>Susan: The 11th Mini AESL Conference was held on April 4. There were 53 faculty from SC, IVC, and TUSD in attendance, and eight in-house faculty presenters, four of which were from SC and four from IVC.</p> <p>Savy: On April 11th, IVC had AESL Awards Celebration for 230 students who earned Certificates of Competency. 	<p>C. WIOA and CASAS Updates</p> <p>WIOA updates were discussed and concerns of federal reduction were shared.</p> <p>Jill: Deliverables are due April 30th. Saddleback College submitted an Integrated English Literacy and Civics Education (IELCE) Report and are revisiting the Continuous Improvement Plan.</p> <p>TUSD: Tustin Adult School just went through WIOA programming review, and</p>	All	1:15 pm

	<p>there was conversation that funds coming from the federal level could also be reduced or potentially some things not being funded at all, as shared by Carmen, the Educational Programs Consultant/WIOA representative from the California Department of Education. The federal department has also been reduced in force, down to an office of 8 from 23.</p> <p>Nancy: This is related to Occupational Training and Adult Education directly. In the past, you all have done a good job of getting SSNs into the system so that the information is pulled directly from the state. Please keep Will and Karima informed of how students are responding as you are requesting SSNs now. The willingness to give that information will probably go way down based on recent actions, so it may mean more work to call students back or send postcards out to reach students, instead of having it be easily pulled directly from the information systems from the state.</p> <p>Will: Q2 closes on April 30th with CASAS.</p> <p>Nancy: WIOA will most likely be moving to the Department of Labor.</p>		
	<p>D. Update on ELL Healthcare Pathways Grant</p> <p>Healthcare Pathways partnership and funding updates shared.</p> <p>Sonja: A team of Saddleback College faculty and administrators will meet with CCA next week to go over a pathway partnership for Medical Assistant students and additional training and program options. The state has announced that Round 3 funding for the ELL Healthcare Pathways Grant will be available and open to all consortia in the state, not just those originally selected and funded in Round 1 and 2, so there will now be an application process.</p> <p>Nancy: The state has previously told us how much money we will get in Round 1 and 2, so now, we'll have to wait and find out our amount for Round 3 during the application process.</p> <p>Karima: The state will also possibly expand Round 1 and 2 because some consortia haven't spent down those funds yet. We're supposed to hear about the Round 3 application process by the end of spring, so hopefully by May. Our workgroup met already to begin discussions for Round 3. IVC is working on partnership or possibly creating new programs with Coastline ROP. The reason the state is opening up Round 3 to all consortia is because not all 71 were not able to participate. NOCE was not identified, including other consortia, so Year 3 will be very different. At the ACCE and CCCAOE conferences that I attended, Gary Adams and Myra Diaz mentioned us as a great model consortia for the ELL Healthcare Pathways regional work. They have also shared our consortium success with state legislatures (using slides from Nancy and Sonja that were presented at the CAEP summit) in order to continue to advocate for adult learners.</p> <p>Debbie: Do Medical Assistant students have to retake a test?</p> <p>Sonja: No, just discussing additional training.</p> <p>Karima: The Department Chair and the Dean of Health and Wellness will be joining our meeting with CCA to talk about how we can work together to not duplicate programs and create pathways for students.</p> <p>Dominic: The administrative aspect is the software because it changes from office to office, so we'll discuss what more SC offers and help with the transition of students from CCA to SC.</p> <p>Karima: We will also discuss CPL we may give to students.</p> <p>Savy: Shared outcomes and surveyed the first cohort. For the Spring 2025 cohort, 31 are licensed with the state board of pharmacy, 20 have been offered jobs, 12 are currently working, 10 are currently working as pharmacy technicians (CVS, Walgreens, Kaiser, Elong Pharmacy), 15 are taking credit courses, and 2 are taking noncredit career education courses.</p> <p>Gina: Some students are hired once their internship is over, and we made progress with CVS this semester.</p> <p>Nancy: Is there any anecdotal information in the ELL cohort that increased their likelihood of staying in and passing class and exam?</p> <p>Savy: We have testimonials. We can find quotes. I want to do that this summer. I can find that information. I survey them every semester and ask how helpful AESL was on a likert scale.</p>	All	1:17 pm

<p>represent their agencies and Nancy could help guide and facilitate the discussion.</p> <p>Nancy: When we originally sent out this agenda, we were discussing whether to allocate COLA funds by percentage or even split. Recently, new information was presented at two sessions and shared with the state, including Niel Kelly and CCTAP. This information is changing how we need to proceed today.</p> <p>We directly asked about our ability to decide how COLA would be split. While legislation specifies that an agency cannot receive <i>less</i> than it did the previous year, it does not explicitly address COLA or other increases. In his response, Niel Kelly clarified that COLA must be distributed proportionally—“percent to total”—as originally intended by legislation. All agencies must follow this method.</p> <p>My question to the state was, what happens when <i>all</i> members are performing well and serving more students? The guidance we received was to refer to our bylaws and the legislation. Niel Kelly reconfirmed: COLA must be split by percentage to total.</p> <p>Rebecca: That’s how we’ve always done it, right?</p> <p>Nancy: Yes. CCTAP also advised using your amendment process to reallocate funds if necessary. That allows for movement between agencies without affecting the overall “percent to total” calculation. However, if a K-12 district or college is requesting a position or program based on an amendment, it’s not allowed because amendments are considered temporary and you can’t hire for permanent roles based on temporary budgets.</p> <p>So, my recommendation to this group—because state guidance has been inconsistent—is to allocate COLA proportionally (percent to total) and, if needed, make amendments for specific projects. Ideally, do this earlier next year so there’s time to work with the state on clearer guidance regarding COLA and performance-based models.</p> <p>As we continue to grow and serve more students, but also face rising costs (e.g., staff raises), it becomes unsustainable. These are big decisions. As your consultant, I recommend proceeding with caution—not just on Niel’s word, but based on what’s required.</p> <p>Will: Regarding past presentations—we’ve operated on a percentage-based model the past two years. We’ve voted for a percentage split, and that’s where these questions originated. If we hadn’t received that directive from Niel, we may have continued discussing an even split.</p> <p>Nancy: You cannot carry over more than 20%, and right now we’re only at 6%. There’s no margin for error in SOCRC, but that’s because all of you did your jobs very well. There have been increases in enrollment, transitions, and job placements—everything the state asks for.</p> <p>Karima: At the last meeting, we presented two options. We got a response Friday night, which I wish we had been able to share earlier. The WIOA webinar that Jill and Sue attended also brought in updates. Niel was on vacation, but still responded. I didn’t name any agencies—just mentioned that two would see permanent reductions under the new interpretation. We’ll need further clarification. We discussed voting on an amendment today.</p> <p>Will: Open for discussion.</p> <p>Susan: If we had voted on an even split, would that have permanently changed the percentages?</p> <p>Nancy: Yes, if the group votes for an even split, it changes each agency’s percentage.</p>

<p>Susan: But how does one-time COLA allow percentages to change?</p> <p>Nancy: You can vote on how COLA is split. If necessary, you can submit an amendment <i>after</i> CFAD is submitted to reallocate differently. I spent weeks creating charts showing how percentages were originally determined.</p> <p>Will: The Ed Code doesn't mention COLA specifically, but says agencies must not receive less than the prior year. That CFAD determines percentage allocations, and COLA should be added on top of those base amounts. If there's a reduction, there might not even be COLA in future years.</p> <p>Nancy: Our position was that legislation referred to dollar amounts, not percentages. The news on Friday contradicted that. Some consortia have never adjusted percentages, but now must.</p> <p>Karima: We've done one-time allocations before and reallocated through amendments. This Friday's info changed that.</p> <p>Brooke: It would've been helpful to have this info this morning. There's still time to preserve existing percentages or consider another option—Option 3: maintain existing percentages using whole numbers, and apply COLA proportionally.</p> <p>Rebecca: Are we working from the original percentages from 11 years ago? How would "whole percentages" work?</p> <p>Brooke: Whole numbers would maintain overall balance.</p> <p>Rebecca: But wouldn't that mean a reduction?</p> <p>Brooke: No, COLA is an increase.</p> <p>Rebecca: It's not mandated that COLA follows original percentages, right? Couldn't we drop IUSD to 10% and then use COLA to restore 10.4%?</p> <p>Brooke: Niel says you can't do that. We were looking holistically. Had we received this sooner, we could've been better prepared.</p> <p>Rebecca: Even adjusting by a tenth of a percent—how does that meet state guidelines?</p> <p>Brooke: Maintaining whole number percentages would honor the original allocations.</p> <p>Debbie: The information feels sudden. We should maintain collegiality—even small percentage changes could benefit everyone.</p> <p>Will: If CFAD isn't submitted by May 2nd, future funds are at risk.</p> <p>Karima: I considered sending it Friday but had to wait for the co-chairs meeting. My gut was to forward it immediately.</p> <p>Brooke: It wasn't intended to be withheld.</p> <p>Rebecca: The agreement 11 years ago has guided us. SC had more involvement due to relationships with CUSD & SVUSD.</p> <p>Debbie: It was based on DRAC funding.</p> <p>Nancy: The state initially based allocation on historical splits. Colleges had apportionment and K-12 had more flexibility. By 2011–12, the state set a baseline effort, and varying amounts were assigned based on perceived AE population. SOCRC helped define those</p>

<p>splits.</p> <p>Rebecca: So how can an agency get more funding if no one else takes less?</p> <p>Susan: What part of Ed Code defines this?</p> <p>Nancy: It's in our bylaws, Sections 7 and 8 on funding. We specifically asked the state about this.</p> <p>Will: The Ed Code allows reallocations if an agency is ineffective or unwilling to participate. That would require discussion at the co-chair level.</p> <p>Rebecca: So we'd need a vote for all agencies to agree to percentage changes?</p> <p>Nancy: Yes. Everyone is performing well. The only way to shift funds is voluntary reallocation—something we've done before. But you can't hire based on temporary funding.</p> <p>Karima: Member ineffectiveness is in the bylaws.</p> <p>Nancy: None of our members are ineffective. Even if they were, state process requires 2 years of technical assistance first.</p> <p>Brooke: The question only went to the state on Friday.</p> <p>Nancy: We didn't expect this shift.</p> <p>Karima: I unmuted during the WIOA meeting to clarify. I represent multiple agencies and considered recusing myself. Nancy isn't reimbursed for travel—only her time. We're just trying to follow the law. We held a vote last year, based on simple majority. We're being as transparent as possible.</p> <p>Nancy: This is an important conversation. Other consortia are also performing well and struggling with the same issue. We need to work with the state on how funds are reallocated when everyone is excelling.</p> <p>Brooke: Appreciate the state-level advocacy.</p> <p>Dominic: Will we vote on COLA distribution every year moving forward?</p> <p>Will: Yes.</p> <p>Nancy: My question is—why is a vote even needed if it's dictated? More to come from the state.</p> <p>Debbie: Hopefully the state provides a memo.</p> <p>Nancy: This info came from a WIOA meeting, not CAEP. Niel works for CDE, not the Chancellor's Office. His interpretation surprised me. We'll request official CAEP guidance.</p> <p>Rebecca: Can we vote on COLA and not CFAD?</p> <p>Nancy: No.</p> <p>Will: We're voting per the agenda—percent to total, even split, or whole percentage option.</p> <p>Susan: I'd like to vote with an asterisk that allows adjustment if we receive new guidance.</p>
